2 DAY CLASSES - SATURDAY AND SUNDAY

301- MASTERING FIREGROUND COMMAND- NOT JUNIOR APPROVED

INSTRUCTOR JOHN SMOOT, CHIEF TEAYS VALLEY FIRE DEPARTMENT, DIRECTOR OF RESA 3 EMERGENCY PREPAREDNESS TRAINING CENTER, RESA 3 INSTRUCTOR.

RESA 3 COURSE

Today's fireground should be calm, orchestrated and controlled incidents. Often it is not! While we are responding to fewer fires, people leaving the fire service, and little or no command training, we have created an era in today's fire service where the simple "bread and butter" house fire is a sentinel event. This class will discuss the NIOSH top 5 line of duty death operational causal factors on the fireground surround...size up, command, communications, accountability and SOP's. Review actual incident video and radio traffic and participate in simulations for house fires, garden/center hall apartments, and commercial occupancies. NOTE- THIS CLASS IS A 12 HOUR COURSE AND WILL NOT START UNTIL 1:00PM ON SATURDAY THE 15TH, THIS CLASS WILL CONCLUDE SUNDAY AFTERNOON.

302- VEHICLE AND MACHINERY SEARCH AND RESCUE AWARENESS AND OPERATIONS (AUTO X)- NOT JUNIOR APPROVED

INSTRUCTOR BILL WEESE, CHIEF TOWN OF MAN FIRE DEPARTMENT, INST. SWVCTC TF 1, INSTRUCTOR RESA 3, LEASA TRAINING DIRECTOR

RESA 3 COURSE

This course will meet the Awareness and Operations level of NFPA 1670 for vehicular rescue. Scene assessment, victim and rescuer safety, accident scene control and management will be covered. Students will be updated on the newest vehicle technology. This class will start in the classroom and move to a hand-on operation concentrating on disentanglement by the use of advanced tools and techniques along with scenario activities. VFIS COURSE

The course is a combination classroom and practical skills training about emergency vehicle operations. Safety, legal aspects, inspection, and driver's responsibilities are all covered. Both written and practical examinations are administered. This class meets the WV State Fire Commission and State EMS initial driver training requirements/recommendations.

304- NIMS 300

WVU FSE COURSE

This course provides training on and resources for personnel who require advanced application of the Incident Command System (ICS). The target audience includes all individuals who may assume a supervisory role in expanding incidents.

Pre-Requisites: ICS-100 & ICS-200

305- WATER MOVEMENT

Will cover Tanker shuttle, drafting, hydrants and many other ways to move water from point A to point B. TURN OUT GEAR REQUIRED

306- INDIVIDUAL CRISIS INTERVENTION AND PEER SUPPORT

INSTRUCTOR- MIKE JARRETT KCEAA CHAPLAIN, EMT B

INSTRUCTOR- SKY KERSHNER, DIRECTOR OF KANAWHA PASTORAL

THIS COURSE WILL BE A PREREQUISITE TO TAKE FUTURE TRAINING IN ESTABLISHING A COUNTY WIDE CISM TEAM- AN ADDITIONAL \$50.00 FEE WILL BE ASSESSED PER STUDENT IF A SPONSOR IS NOT FOUND PRIOR TO THE COURSE FOR RESOURCE FEES.

Crisis Intervention is NOT psychotherapy; rather it is a specialized acute emergency mental health intervention, which requires special training. As physical first aid is to surgery, crisis intervention is to psychotherapy. Thus, crisis intervention is sometimes called "emotional first aid". This program is designed to teach participants the fundamentals of, and a specific protocol for, individual crisis intervention.

This course is designed for anyone who desires to increase their knowledge of individual (one on one) crisis intervention techniques in the fields of Business and industry, Crisis intervention, disaster response, education, Emergency Services, Employee Assistance, Healthcare, Homeland Security, Mental Health, Military, Spiritual Care, and Traumatic Stress.

101- ART OF READING SMOKE - 4 HR CLASS (MORNING)

One of the most important size-up skills an officer or firefighter can have is the ability to capture, in an instant the size of a fire and the potential for a rapid, hostile fire event like flashover or smoke explosion. Often smoke issuing from a structure is the only clue available to predict fire behavior. This course gives first-due fire officers and firefighters a process to Read smoke and predict hostile fire events.
