Lodging

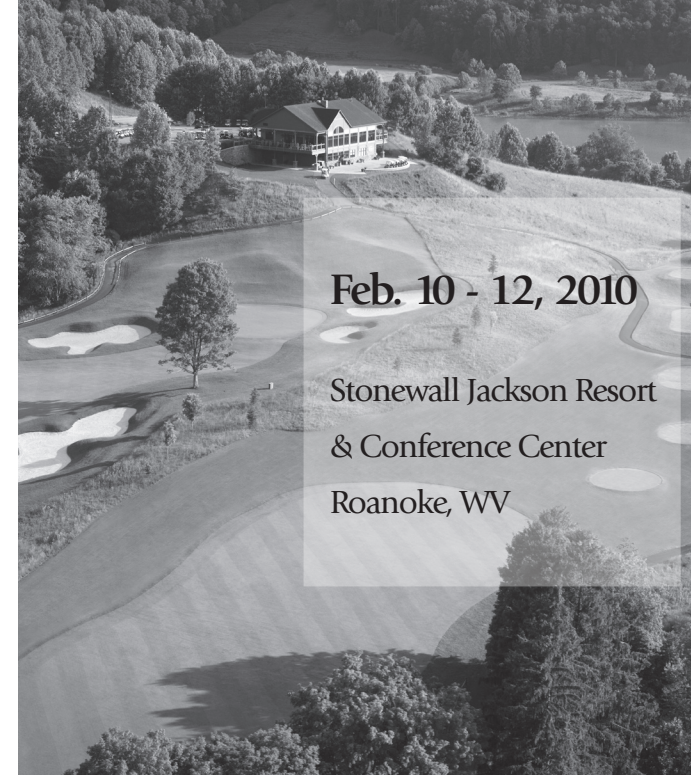

Conference Overview and Objectives

We would like to invite you to the 2010 West Virginia Trauma Symposium to be held at the Stonewall Resort, Roanoke, WV. This conference is designed for trauma surgeons, general surgeons, emergency room physicians, nurses, mid level providers and prehospital health care, coding specialists and health information professionals. A registrar workshop will be presented as a separate meeting during the opening day of the conference. All registrars working in the trauma arena are encouraged to attend. This conference will represent a collaborative effort between experts in various trauma disciplines from around West Virginia. A three-hour Trauma Nursing Workshop will be held on the opening day of the conference featuring topics on neurological trauma and complications. The speakers will present progressive and challenging issues in the field of trauma care. The State Trauma Audit Review/ State Trauma Audit Committee meetings will begin Friday afternoon Feb. 12 and conclude on Saturday, Feb. 13, 2010. All conference attendees are invited to attend.

At the conclusion of this program participants should be able to:

- Discuss current trends in cerebral resuscitation
- Identify current strategies in the management of abdominal wall reconstruction surgery
- Review the new surgical techniques in spine trauma
- Review complications identified in the vascular trauma population
- Discuss treatment of peri-prosthetic fractures
- Identify common mechanisms of injury and complications of orbital trauma
- Identify risks and complications of CVA post blunt neck trauma
- Identify current treatment strategies of care for the geriatric trauma patient
- Recognize trauma assessment guidelines and when to transfer
- Describe current treatment strategies for the evaluation of speech and swallowing in the trauma patient
- Discuss the treatment of gunshot wound to the face with reconstruction
- Review the use of ultrasound in the emergency department
- Describe current treatment in the care of the traumatic brain injury patient
